**Workflow and Payment**

Prices are based on 1 set or up to 1 hour. Mike Goetz Productions will arrive 30 minutes early for setup. We will bring a printed agreement for The Act/Contact to initial their electronic signature, secure the venues wi-fi (to increase transfer speed), confirm play times, and determine access (stage, wings, backstage, floor only).

We will perform the live media services agreed upon in this document. For best result, we recommend two cameras. Videos will be segmented into predetermined pieces for easy upload.

At the end of our filming day, we will we will transmit all files digitally to your desired email address via Google Link. Files can also be transmitted directly to your phone via Superbeam. (Download app at <https://superbe.am/>). Please allow additional time for Superbeam upload.

We will request payment upon the delivery of all assets. If there are multiple items, Mike Goetz Productions will deliver all items at the same time. Upon completion, the Act/Contact agrees to payment by Cash, Venmo, Paypal, or Quickpay with Zelle. We do not accept checks.

**Liability**

The Client and agrees to defend, indemnify, and hold The Videographer harmless from any lawsuits, claims, or other legal actions, by any person or entity against The Videographer arising out of any and all work performed by The Videographer under this contract. Mike Goetz Productions will do everything possible to deliver quality recordings. We are not responsible for footage affected by fans passing in front of the camera, or other crowd-related mishaps.
